

# **Trial Terms of Use**

Trial access of the SPIE Digital Library is made available to your institution for a limited trial period, at no charge, solely for the purpose of evaluation. It is understood that you and your institution accepts and agrees to the TERMS OF USE detailed below the first time you access the SPIE Digital Library and until the trial period is concluded.

#### **AUTHORIZED USERS**

- SPIE grants to Authorized Users at Client's facility online access to the SPIE Digital Library for the trial period.
